

COOPERATION AGREEMENT
Between
HEBEI FOREIGN STUDIES UNIVERSITY, CHINA
And
ANTALYA BILIM UNIVERSITY, TURKEY

HEBEI FOREIGN STUDIES UNIVERSITY, hereinafter also **HFSU**, with headquarters at No. 29 Huifeng West Road, Shijiazhuang City, Hebei Province, China, represented by its President Prof. Jianzhong Sun, and the **ANTALYA BILIM UNIVERSITY**, hereinafter also **ABU**, with headquarters at Mahallesi Gazi Bulvarı No:531 07310 Antalya, Turkey, represented by Dr. YUKSEK ISMAIL, agree to sign this Cooperation Agreement, subject to the laws of their countries and to international law, assenting to the following clauses and conditions:

CLAUSE I

Object

The main purpose of the present agreement is to establish academic cooperation between **HFSU** and **ABU** in the following activities:

- A) Student Exchange**
- B) Dual Degree Program**
- C) Chinese Language and Culture Courses**
- D) Faculty Exchange**
- E) Any other activity of mutual interest regarding academic or scientific and technological research matters.**

Clause II

Academic Cooperation Programs

The institutions shall pursue the following modes of cooperation:

1. Students Exchange

over and above the mutually-agreed number will be charged the standard tuition fees by the hosting institution.

3) Exchange students will be selected by their home university and accepted by the host institution.

2. Dual Degree Programs

It is hoped that HFSU students shall study at their home institutions for two years and be accepted by ABU if they are academically qualified and study at ABU for two years to get a degree after successful completion of their study at ABU. HFSU will recognize the credits the students get from their study at ABU. The courses that the students will take

English or better Chinese and who can teach Turkish language at HFSU for one semester or one year. HFSU will pay the candidate and cover the cost of international travelling.

5. Internship Positions

HFSU may provide one or two Internship positions for language students from ABU who can also speak English or better a little Chinese for a period of one semester or one year.

Clause III

Term and Termination

1. This agreement shall only be valid when signed by the Rector of ABU (or his/her nominee) and President of HFSU (or his/her nominee).
2. This agreement shall be valid for a period of five years from the date of signature. At the termination of this period both institutions, by mutual agreement, may extend the term.
3. This agreement may be revised and changed by mutual agreement when the further needs arise from either side.
